

Official Rules for the Lexmark Photobucket Design Contest

The following rules apply to the Contest. No purchase necessary. Entrants must be residents of the United States, Canada, Mexico, Brazil, Australia, UK, Germany, France or South Africa, be 18 years of age or older and be a member of the Facebook social networking platform.

Employees of Lexmark International, Inc. ("Lexmark" or "Sponsor") and Photobucket, and their respective affiliates, subsidiaries, and such employees' immediate families, are not eligible to participate. Contest period is Wednesday, October 6, 2010 through Friday, November 12, 2010.

Prizes

- Redecorate your old printer in a creative way and photograph it.

Photos showing identifiable persons, places, or non-Lexmark branded products are ineligible for entry.

Photos submitted during the Contest period (see above) will be uploaded as received into the Facebook albums of both Photobucket and Lexmark. Voting will be open from 12:01 AM EST on October 15, 2010, until 11:59 PM EST on Friday, November 12, 2010. Facebook members can cast votes by "Tagging" themselves in the photo entry of their choice. Voters can self-tag more than one entry. One vote will be counted for each individual tag. No single entrant can win more than one prize. The five entrants whose photos have the largest number of votes will each win one prize.

Winners will be notified by the same social media outlet in which they entered or by electronic mail after November 12, 2010. Winners may not substitute or transfer prizes.
